	Minimum two (2)-Maximum six (6) Teeth.
	Live animal weight should not be less than 170 KG and should not be more than 200 KG.
	Average weight of meat of each animal should not vary by more than 10% (minimum 100KG weight – Maximum 120KG weight of clean meat)
	Milking cow will not be accepted
	All Heifer must not have given birth
	Animal should not have any physical defects and disease i.e. Congo virus blindness, lumpy skin, missing/ broken limb, and damaged horns or any other disability.
	If any of the animal seems weak or with any physical defect of any kind, will not be acceptable and vendor has to provide alternate animal.

		They must be able to walk without limping
		They should not be blind or have lost a third or more of their sight.
		The average live weight of a goat for Qurbani is between 25-30 kg, and the meat weight is approximately 12-14 kg.
		Milking cow will not be accepted
		All Heifer must not have given birth
		Animal should not have any physical defects and disease i.e. Congo virus blindness, lumpy skin, missing/ broken limb, and damaged horns or any other disability.
		If any of the animal seems weak or with any physical defect of any kind, will not be acceptable and vendor has to provide alternate animal.
